Proses Engineering Treatment Systems Construction Co. EXPLANATION TEXT ON THE PROTECTION AND PROCESSING OF PERSONAL DATA

1. Purpose:

Proses Engineering Treatment Systems Construction Co. ("PROSES" or "Company") aims to process personal data of personal data owners (Annex-1 Explains Personal Data Owners Table) in accordance with the provisions of Personal Data Protection Law No. 6698 ("KVK Law") and other legislation.

Your personal data that you have/will notify to our Company and/or provided by our Company by any external means, as "Data Controller" by our Company,

- Within the framework of the purpose that requires the processing of your personal data and in connection with this purpose, limited and in moderation,
- By maintaining the accuracy and the most up-to-date version of the personal data you have notified or reported to our company,
- It will be recorded, stored, preserved, rearranged, shared with the institutions that are legally
 authorized to request this personal data and transferred to domestic or foreign third parties,
 transferred, classified and processed in other ways listed in the KVK Law, under the conditions
 stipulated by the KVK Law, and We inform you that it may be subject to other processes listed in
 the KVK Law.

With this "Lighting Text", it has been adopted to continue and develop the activities carried out by PROSES in accordance with the principles in the KVK Law.

2. Terms of Processing Personal Data:

The express consent of the personal data owner is only one of the legal grounds that enables the processing of personal data in accordance with the law, and in the presence of one of the following conditions, personal data is processed by our Company without seeking the explicit consent of the data owner.

Except for express consent, the basis of the personal data processing activity may be only one of the conditions stated below, or more than one condition may be the basis of the same personal data processing activity.

- Explicitly Provided in Laws: If it is expressly envisaged in the law, in other words, if there is a clear provision in the law regarding the processing of personal data, the personal data of the data subject may be processed by our Company within the framework stipulated in the legislation.
- Failure to Obtain the Explicit Consent of the Related Person due to Actual Impossibility: In case
 the personal data of the person who is unable to express his/her consent due to actual impossibility
 or whose consent cannot be validated is required to be processed in order to protect the life or
 bodily integrity of himself or another person, the personal data of the data owner may be
 processed.
- Being Directly Related to the Establishment or Performance of the Contract: Provided that it is
 directly related to the establishment or performance of a contract to which the data owner is a
 party, this condition may be deemed to have been fulfilled if the processing of personal data is
 necessary.
- The Company's Fulfillment of its Legal Obligations: In case data processing is mandatory for our company to fulfill its legal obligations, the personal data of the data owner may be processed.
- Publicizing the Personal Data of the Personal Data Owner In case the data owner has made his
 personal data public, the relevant personal data may be processed for the purpose of making it
 public on a limited basis.
- Obligatory Data Processing for the Establishment or Protection of a Right: If data processing is mandatory for the establishment, exercise or protection of a right, the personal data of the data owner may be processed.

4. Purposes of Processing Personal Data and Legal Reasons

Obligations, Occupational Health and Safety Law, Tax Procedure Law, Income Tax Law, Corporate Tax Law, Stamp Tax Law, Value Added Tax Law and the legislations listed. In particular, in order to fulfill legal obligations and requirements;

In terms of our subcontractors and suppliers:

- Making the stamp tax declaration notification, Notifying the purchase and sale of goods and services.
- Making notifications regarding the purchase and sale of goods and services,
- Making the concise declaration notification,
- Value added tax return, provisional tax return, corporate tax return
- making notifications,

For the purpose of establishment and performance of the contract, in particular;

- Recruitment/supply of personnel,
- Employee employment/periodic examination,
- Conducting employee inspection,
- Preparation, approval and recording of progress payments,
- · Minutes and recording of the work done and delivered,
- · Processing invoices from vendors,
- Opening a record in the system for the seller.
- · Follow-up of purchase orders,

In accordance with the legitimate interests of the data controller and for the implementation of our Company's policies, in particular;

In terms of our employee and employee candidates;

- Submitting SSI declaration,
- Making the Stamp tax declaration notification of the Employment Contract,
- Supervision of the duties and authority given to the personnel in the company,
- Ensuring the operation of the company.

For the purpose of establishment and performance of the contract, in particular;

- Evaluation of personnel background and work experience
- Employee employment/periodic examination,
- Submitting SSI monthly statements,
- · Payment of salary and other labor rights, if any.
- Keeping the personnel files physically and electronically, provided that they remain within the employer's retention and submission period in accordance with the Occupational Health and Safety, Social Security Law and Labor Law,

In particular, in order to implement our company's policies;

Your personal data, until the disappearance of the purpose specified in the relevant legislation or processing. It will be retained for the reasonable period of time that will elapse and, possibly, for the statutory statute of limitations.

5. Transfer of Personal Data to Third Parties

In order to fulfill legal obligations and employment contract requirements, including but not limited to Income Tax Law, Corporate Tax Law, Tax Procedure Law, Labor Law and Social Security Law, Occupational Safety and Health Law and these legislations; It can be transferred to the Revenue Administration, the General Directorate of Security, the relevant employees of our Company, the related companies and the group company.

Transfer of Personal Data to Domestic Third Parties;

In particular, in order to fulfill legal obligations pursuant to Income Tax Law, Corporate Tax Law, Tax Procedure Law, Labor Law, Social Security Law, Occupational Safety and Health Law and applicable legislation, laws, regulations and communiqués;

- Evaluation of personnel background and work experience
- Employee employment/periodic examination,
- Submitting SSI monthly statements.
- Payment of salary and other labor rights, if any.
- Keeping the personnel files physically and electronically, provided that they remain within the
 employer's retention and submission period in accordance with the Occupational Health and
 Safety, Social Security Law and Labor Law.
- Recording all of the above written matters,
- Making the stamp tax return declaration.
- Making notifications regarding the purchase and sale of goods and services,
- Concise declaration, value added tax return, provisional tax return, corporate filing tax returns,
- It can be transferred to the relevant OHS specialist or legal entity on Social Security Institution and Occupational Health and Safety.

6. Ensuring the Security and Confidentiality of Personal Data

In accordance with Article 12 of the KVK Law, our company takes all necessary technical and administrative measures to ensure the appropriate level of security in order to prevent the unlawful processing of the personal data it processes and the unlawful access to personal data, and to ensure the protection of personal data.

6.1 Technical Measures Taken to Ensure Legal Processing of Personal Data and to Prevent Unlawful Access to Personal Data

- Taking technical measures to the extent that technology allows
- Recruitment of experts in technical matters
- Auditing the implementation of the measures taken at regular intervals
- Creation of necessary software and infrastructure to ensure security
- Limitation of access to data being processed within the company
- Using the backup program in accordance with the law to ensure the safe storage of personal data
- Use of software containing virus protection systems

The company has taken all kinds of technical and technological security measures to protect your personal data.has protected your personal data against possible risks.

6.2 Administrative Measures to Ensure Legal Processing of Personal Data and to Prevent Unlawful Access to Personal Data

- Training and raising awareness of company employees regarding the KVK Law,
- In cases where personal data transfer is in question, ensuring that a record is added to the contracts concluded with the persons to whom the personal data is transferred, stating that the party to which the personal data is transferred will fulfill the data security,
- Determining what needs to be fulfilled in order to comply with the KVK Law and preparing internal policies for their implementation,

6.3 Measures to be Taken in Case of Unlawful Disclosure of Personal Data

• In case the processed personal data is obtained by others illegally, our Company will notify the relevant data owner and the Management as soon as possible.

7. Deletion, Destruction and Anonymization of Personal Data

Pursuant to Article 7 of the KVK Law, although the personal data has been processed in accordance with the relevant legislation, the personal data is deleted, destroyed or anonymized by our Company, ex officio or upon the request of the personal data owner, in case the reasons for processing are no longer valid.

The procedures and principles regarding this matter will be fulfilled in accordance with the KVK Law and

the secondary legislation to be formed on the basis of this Law.

7.1 Techniques for Deletion and Destruction of Personal Data

• Example: physical destruction, soft soft wipe, expert secure wipe, etc.

7.2 Techniques for Anonymization of Personal Data

• It means making personal data in a way that cannot be associated with an identified or identifiable natural person under any circumstances, even by matching with other data.

8. Rights of Personnel/ Personnel Candidate

Pursuant to Article 11 of the KVK Law, you can apply to our Company about your personal data as follows:

You can make requests regarding:

- Learning whether personal data is processed or not,
- If personal data has been processed, requesting information about it,
- To learn the purpose of processing personal data and whether they are used in accordance with the purpose,
- Learning the third parties whose personal data are transferred in the country or abroad,
- Requesting correction of personal data if it is incomplete or incorrectly processed, and Requesting notification of the transaction made within the scope of the transaction to the third parties to whom the personal data has been transferred,
- Requesting their deletion, destruction or anonymization in the event that the reasons requiring
 the processing of personal data disappear, and requesting the notification of the transaction
 made within this scope to the third parties to whom the personal data has been transferred,
- By analyzing the processed personal data exclusively through automated systems.to object to the emergence of a result against the data owner.
- In case of damage due to unlawful processing of personal data, don't demand removal.

9. Rights of the Subcontractor / Supplier

Pursuant to Article 11 of the KVK Law, you can apply to our Company about your personal data as follows: You can make requests regarding:

- Learning whether personal data is processed or not,
- If personal data has been processed, requesting information about it,
- To learn the purpose of processing personal data and whether they are used in accordance with the purpose,
- Learning the third parties whose personal data are transferred in the country or abroad,
- Requesting correction of personal data if it is incomplete or incorrectly processed, and requesting
 the notification of the transaction made in this context to the third parties to whom the personal
 data has been transferred.
- Requesting their deletion, destruction or anonymization in the event that the reasons requiring
 the processing of personal data disappear, and requesting the notification of the transaction
 made within this scope to the third parties to whom the personal data has been transferred.
- By analyzing the processed personal data exclusively through automated systems. to object to the emergence of a result against the data owner,
- Requesting the compensation of the damage in case of loss due to unlawful processing of personal data.
